

CONSENT TO ADD MEMBERS TO A WHATSAPP BROADCAST LIST AND TO A WHATSAPP GROUP

WhatsApp broadcast list: BIYSC 2025 PARTICIPANTS WhatsApp group: BIYSC_2025_(Project)

In accordance with the provisions of the Regulation (EU) 2016/679 of 27 April, 2016 on the protection of personal data (GDPR) and the Spanish Organic Act 3/2018, December 5 (LOPDGDD), we request your consent to include you in the <u>WhatsApp broadcast list: BIYSC 2025 PARTICIPANTS</u> and the <u>WhatsApp group</u> <u>BIYSC 2025 (project)</u> responsibility of **FUNDACIÓ CATALUNYA LA PEDRERA**, with the sole purpose of managing the development of the BIYSC 2025 Program, for which the following information regarding the processing is provided:

Members: Those who belong to the group and the broadcast list at the time of sending a message will be considered members of the groups, so both former members and future members who are not part of the group and the broadcast list at that time are not considered recipients of the data. The group and the broadcast list administrator may add or remove any member without notice. Data recipients: Your name, telephone number and conversations provided to the group will be visible to other members of the group who have also given their consent to achieve the indicated purpose. Use of the data: It is strictly forbidden to use the information contained in the group and the broadcast list for other purposes, including communication to third parties outside of the group or the broadcast list. Data retention criteria: While belonging to the group and the broadcast list, you must save the history of conversations that are necessary for the purpose described. When a member is expelled from any of the group or the broadcast list, all conversations must be immediately deleted, unless any of the conversations is required by a legal obligation or for the legitimate defense of the expelled member, in which case all the information must be blocked and limit its processing as long as responsibilities can be derived from its relationship with the other members of the group. The data will be kept for the time necessary to maintain the purpose of the processing. Once the data is no longer necessary for such purpose, the data will be suppressed by blocking it during the time frame established by law, taking technical and organizational measures to prevent the processing of the data including its visualization, and being only available to judges, courts, public prosecutor or public administrations to respond, to respond to legal duties. Subsequently, after the suppression or blocking period, the data will be erased. International transfers: We inform you that although the servers of the WhatsApp application for EU users are located in Ireland, communications with US servers may be given for technical reasons that would involve an international transfer of data. Therefore, we request your explicit consent to be able to send you communications by this means, which you can revoke at any time. Data subject rights: Right to withdraw consent at any time. Right of access, rectification, portability and erasure of your data and the right to restrict and object to them being processed by communicating it to the administrator of the group or the broadcast list through a private WhatsApp message. Right to lodge a complaint with the Supervisory Authority (www.aepd.es) if you consider that the processing does not comply with the current legislation.
