



## **AUTHORISATION FOR THE USE OF IMAGES**

### **MINORS FROM 14 TO 18 YEARS OF AGE**

**CATALUNYA LA PEDRERA FOUNDATION** with ID number G65345472 is the Controller for the processing of the personal data of the participant of the program and informs that the personal data will be processed in accordance with the provisions of the regulations in force on the protection of personal data, the General Data Protection Regulation of the European Union EU 2016/679, April 27 (GDPR) and the Organic Law 3/2018, December 5 (LOPDGDD) and the Law 1/1982 on civil protection, the right to honour, right to personal and family privacy. Accordingly, you are provided with the following information regarding the processing.

**Purpose of the processing:** recording of images and videos of the activities carried out by the Controller and the entities of the group for subsequent publication in the different means of communication and dissemination of the organisation such as websites, portals, intranet, blogs, social networks, internal or external newsletter, etc. your name and position may be indicated. The authorisation herein is granted free of charge, without the data subject having the right to claim any amount from the Data Controller because of this.

**Lawful ground for the processing:** the processing of your personal data, including the images, is based on the consent you are giving by signing this authorisation and, you are informed that you can withdraw your consent at any time.

**Data retention criteria:** the personal data will be kept during the necessary time to maintain the purpose of the processing and/or as long as the data subject does not revoke the consent. Once the data is no longer necessary for such purpose, the data will be suppressed by blocking it during the time frame established by law, taking technical and organisational measures to prevent the processing of the data including its visualization, and being only available to judges, courts, public prosecutor, or public administrations, to respond to legal duties. Subsequently, after the suppression or blocking period, the data will be erased.

**Communication of the data:** images and recordings may be published by third parties, media, websites, and social networks.

**Rights assisting the Data Subject:** Right to access, rectification, portability, and erasure of the data and rights of restriction and to object to the processing of the data.
